Geoff Hansen's Wurlitzer in Hunter Hall, Rio Vista; then the good old, now-installed (32 years ago), Chapter-owned Fair Oaks Wurlitzer; and next the Robert Morton organ at Ironstone Vineyards. Then there was our picnic/potluck concert at **Pete and Dianne McCluer's** home in the foothills where we heard their mighty Wurlitzer. 
Above is the massive pedalboard for Cameron Carpenter's new touring organ.
